As sustainable development has become a pivotal framework for social progress globally, this study analyses how the film integrates these goals into its narrative. Kaṭaici Vivacāyi offers a unique perspective on pressing global issues and environmental degradation, serving as a vital medium for raising awareness and fostering dialogue on these interconnected challenges. The analysis reveals the film's alignment with contemporary SDGs, vividly portraying various social and environmental issues such as industrial animal farming, hybrid seed usage, urbanisation, and the practices of farmers within an industrialised context. The framework of the 17 Sustainable Development Goals provides a foundation for understanding the processes of sequencing, initial coding, and both direct and indirect open coding. Furthermore, the themes identified are rooted in the three pillars of sustainable development social, economic, and environmental—which are intricately woven into the narrative style of films addressing these issues. The study also delves into the themes derived from the data, highlighting the interconnectedness of the film's narrative with the broader objectives of sustainable development.

Environmental sustainability is a central theme in Kaṭaici Vivacāyi, where the protagonist's farming methods are deeply rooted in harmony with nature. The film critically examines the adverse impacts of contemporary agricultural practices, highlighting issues such as soil degradation, water scarcity, and the decline of biodiversity. By employing organic and low-input farming techniques, the farmer not only promotes environmental sustainability but also conserves vital natural resources and maintains ecological balance. His deliberate choice to forgo hybrid seeds and synthetic fertilisers serves as a powerful statement against environmentally damaging practices. The farmer's profound spiritual connection to the soil embodies a commitment to climate action and the intrinsic value of life sustained by healthy soil. Kaṭaici Vivacāyi effectively addresses the three pillars of sustainability—economic viability, social cohesion, and environmental integrity—by advocating for the preservation of traditional agricultural methods. The film underscores the multifaceted nature of sustainable development, which encourages

positive interactions with the environment and emphasises the importance of protecting against environmental degradation. It highlights the necessity of responsible stewardship of natural resources, focusing on waste reduction and pollution control. Furthermore, the environmental dimension of sustainable development goals encompasses the interplay between natural ecosystems and social issues, including waste management and greenhouse gas emissions. The term "environmental" relates to the various elements of an organisation's products, operations, and services, as well as their interactions with the surrounding environment. This interconnectedness reveals three levels of ecological and biophysical vulnerability that are at risk of harm and degradation. Ultimately, the concept of environmental wellness, integral to sustainable development goals, fosters overall health and well-being, emphasising the profound impact of environmental conditions on human health and quality of life.

The protagonist's solitary life serves as a poignant representation of the isolation faced by traditional farmers as they grapple with the potential extinction of their way of life. The narrative advocates for the preservation of rural communities, the safeguarding of local customs, and the promotion of indigenous agricultural practices, while also envisioning sustainable urban environments and the goal of eradicating hunger. The social dimension encompasses various elements, including higher education, community development, and technological advancements, all of which play a crucial role in addressing the needs of both privileged and marginalised groups. This dimension also addresses economic support, counselling services, and governance solutions, reflecting a comprehensive approach to community development. Furthermore, the spatial aspect of this social component can be likened to an ecosystem, aiming to extend its influence beyond geographical confines. Within the framework of sustainable development goals, the social dimension is integral to achieving a balance between social, economic, and environmental sustainability, emphasising the importance of nurturing interpersonal relationships and fostering cooperation within society. Human behaviour, shaped by social norms, communication practices, and conflict resolution strategies, is essential for cultivating a thriving community.

It effectively portrays the unsustainable nature of current agricultural methods and underscores the urgent need for more equitable and sustainable development approaches. The narrative reveals how the high costs associated with premium seeds place a considerable burden on farmers' budgets, exacerbating their economic stress. Many farmers, as depicted in the film, feel compelled to boost their production levels to meet market demands, even if this requires incurring additional expenses linked to sustainable development goals. Furthermore, the film raises critical concerns regarding the long-

term viability of relying on high-yield seeds, which can contribute to soil degradation and a cycle of dependency on the Sustainable Development Goals (SDGs). Additionally, Kaṭaici Vivacāyi sheds light on the economic pressures stemming from rising pesticide costs, emphasising that the management of pests and diseases often necessitates the use of chemical pesticides. These pesticides, while intended to protect crops, can significantly strain farmers' finances, potentially leading to indebtedness and economic hardship. The film also highlights the detrimental environmental impacts of excessive pesticide use, which can contaminate soil, reduce fertility, and create lasting challenges for agricultural sustainability.

The analysis of the research film provides a comprehensive insight into the Sustainable Development Goals (SDGs), which address critical environmental, social, and economic dimensions. The Kataici Vivacāyi Tamil film poignantly illustrates the challenges encountered by marginalised rural communities striving to escape poverty and enhance their living conditions. It places particular emphasis on the significance of gender dynamics within agricultural and rural contexts, spotlighting the empowerment of women in both agricultural practices and decisionmaking processes.
